


PRESIDENT'S COLUMN



### SARASOTA: Camp Commentary

For me, the outstanding event of this year's camp was the Sunday night bonfire. After listening to Dr. Wixman hold forth on the communal function of folk dance in the Balkan village and the "hora" as an outdoor gathering where music and dance take place spontaneously, we finally got a taste of what he was describing.

Craig had gathered up limbs and branches and skillfully set them ablaze. Campers gathered around. Terry started us down memory lane by playing old camp songs on her accordian. She then picked up the melodies as other people reminisced...there were even verses made up on the spot. Terry accompanied (our guests from Charleston, S.C.) Olga and Elena Bell's Russian nostalgia with Moscow Nights and then went on to the Volga Boatmen. (sic)

It occurred to me as we stood under the stars and a sliver of a moon that we should get away from the four walls, the hard floor, the electronic tapes and above all the regimented classes and make use of . that beautiful Camp Ocala lake area as a setting for a "hora", a "kolo", a GATHERING and try to experience folk dance as a natural, spontaneous outdoor happening with the main objective being to build community and have a good time, rather than to compulsively work to "take home one more dance".

Personally, I have been attending FFDC camps for ten years and I decided to graduate myself: I have now met all the requirements and I no longer need to learn "one more dance". (I am interested in improving the ones I already know, but I am thru collecting.)

I would like to find out if anyone else has arrived at this opinion.

- No paid instructors.
- Two simultaneous morning dance classes taught by Floridian experts: one indoors, one out.

Paid musicians who have a large repertory of folk dance music. None of the above, I like it just as it is. My suggestions are:

### GREETINGS from MIAMI

No, you are not hallucinating; this is a real communication from your "Miami Connection". Several things have prompted me to submit this article. First, two people at the workshop said to me,"Phyllis, why don't YOU submit an article to the newsletter?" Can't get any more direct than that! Second, several people mentioned that they were told that our groups had disbanded after Ginny Corwin died. The truth is, we cancelled one class after that very tragic loss, and then never missed a beat after that. We are alive and well, guys!

The other motivation for writing stems from a desire to offer some feedback regarding the workshop. There are three elements that compose my experience each year - the pure fun of concentrated folk dancing, reconnecting with people who share the same passion for folk dancing as I do, and being able to bring back new dances to my local group. The first two were extremely rewarding. The third, however, fell short of its usual high standards, in my opinion, for several reasons.

To begin with, some of those dances seemed more appropriate for for stage productions. They were elaborate, complex and more adaptable for performing groups than for recreational groups. A few complex dances are appropriate and exiting to be sure, but to spend entire sessions on just one of them was a bit excessive. I thought the time would have been better spent teaching two or three dances per session of varying levels of complexity.

I also did not appreciate repeating Bunjevacko Momacko Kolo. We learned that a few years ago from Dick Crum. Perhaps someone should be assigned the responsibility of reviewing the teaching program with the instructors in advance to avoid repetition, thus deriving the most benefit of new material as possible.

I also though that excessive reviewing during party time was inappropriate. Ron took up what seemed to me a very big chunk of our

party time with anecdotes and background information which, although interesting and amusing, would have been more appropriate for Culture Corner.

I hope I don't sound sour. Many things made my experience a very positive one. The basic organization of the whole operation was excellent. The parties for the most part were high-spirited and lots of fun. And, each time I come, I feel more in the mainstream of the dancing as I increase my own repertoire and gratefully accept the onthe-spot help from dancers of different groups. The camaraderie is heartwarming and, in my opinion, every bit as important as the more technical aspects of the workshop.

It is because I care very much about the quality of our experience each year that I feel compelled to bring up these areas of possible improvement to be considered by all of us. Incidentally, I recently spoke to Ira Weisburd, another group leader, and he shares my views on these concerns.

This is really the first time I have taken an official public stand on folk dance issues beyond the scope of my immediate group, and would welcome feedback on what I have said, both in agreement or not (be gentle please!).



In an effort to expedite publication of this newsletter we are going to try something. I am going to try to use your submitted material directly. Please submit material as follows:

- a) To keep some degree of uniformity of appearance, if possible use a typewriter or printer with similar style 12 characters-perinch type.
- b) Material <u>must</u> be single-spaced and fit in a column 5  $\frac{15''}{16}$  wide.
- c) Use a good typewriter/printer ribbon.
